2017 Curriculum of <u>Finance</u> for GDUFE Full-time Postgraduate International Students

- I. Study Length: 2 academic years, a maximum of 4 academic years
- **II. Course Design and Assessment:** The courses include compulsory and optional courses. The assessment includes examination (closed-book exams and open-book exams), course thesis, oral test, experiment design, etc. Students, who pass the assessment and obtain at least 60% of the total score, can get the credits.
- **III. Other Cultivation Items (including specialized practice):** 5 credits, among which, 4 credits are for specialized internship, 1 credit for taking part in lectures and forums, academic science and technology competitions as well as literature reading.
- **IV. Graduation and Degree Requirements:** International students, who obtain the required 39 credits (34 course credits and 5 for other cultivation items), finish specialized practice and other cultivation items, complete graduation thesis, and pass the thesis defense, can graduate with a diploma and a professional master degree of Finance. Master thesis and thesis defense should meet the following requirements: (1) thesis should reflect characteristics of professional degree, making study serve the practical purpose, focus on solving practical problems and graduation thesis can be in the form of case analysis, research reports, product design and solutions to practical financial issues and so on; (2) the whole process mainly include topic selection and proposal, pre-defense and defense; (3) the thesis committee members, should include experts with advanced professional titles of finance or economic management and 1/3 of the experts should be from other institutions.
