# **Teaching Program for Taxation (Certified Tax Agents)**

## 1. Training Goal:

2. School Year: 4 years full-time

3. Degree Awarded: Bachelor of Economics

**4. Credit Requirements:** The students should obtain 155 credits (off-class credits not included), including liberal compulsory courses for 50 credits, liberal optional courses for 9 credits, the foundational courses for 46 credits, compulsory courses for 33 credits, optional courses for 6 credits and synthetically applied courses for 11 credits. In the meantime, students should obtain 10 credits from off-class programs, and take the course "Health Education for Undergraduates".

#### 5. Requirements for Students from Hong Kong, Macao and Taiwan

According to the Education Department of Guangdong Province, the students from Hong Kong, Macao and Taiwan need not take courses from the sections of "Education of National Defense" and "Theory of Ideology and Politics". The students should strictly follow the teaching program, taking courses of the other sections.

## 6. Requirements for Overseas Students

According to Ministry of Education an Education Department of Guangdong Province, oversea students need not take courses from the

section "Education of National Defense". Oversea students of economic disciplines should take courses of political theory, while the students of other disciplines could apply to be excused from it. The oversea students who receive education with record of formal schooling should take courses "Chinese" and "A Survey of China". Other courses should be taken strictly by the teaching program.
